## WHO IS RESPONSIBLE FOR THE PROCESSING OF YOUR DATA?

## FOR WHAT PURPOSES WILL YOUR PERSONAL DATA BE PROCESSED?

The Controller identified above processes the information provided by data subjects for the following purposes:

- To send communications to the data subject regarding opportunities related to franchise operations or other forms of hotel management.

## WHAT IS THE LEGAL BASIS FOR THE PROCESSING?

The legal basis for the processing activities described above is:

- Consent.

Withdrawal of consent by the data subject may result in the Controller being unable to continue providing information regarding opportunities related to franchise operations or other forms of hotel management.

## WHO ARE THE RECIPIENTS OF YOUR DATA?

Your data may be disclosed to:

- Companies forming part of the same group as the Controller.

- Entities outside the Controller's corporate group with which the Controller may have agreements concerning business opportunities linked to its activity and corporate purpose.

## **INTERNATIONAL DATA TRANSFERS**

Likewise, please note that your data may be transferred to countries outside the European Economic Area due to the presence of the Joint Controllers in third countries, as well as to non-group entities also located in third countries with which the Controller may have agreements concerning business opportunities linked to its activity and corporate purpose.

## **HOW LONG WILL WE RETAIN YOUR DATA?**

The personal data provided by the data subject for the purpose of formalising and managing the contractual relationship will be retained for as long as the consent granted by the data subject remains valid and in force.

## **WHAT ARE YOUR RIGHTS?**

You may exercise, at any time and free of charge, the following rights by sending a written request to the Controllers at Calle Santa Engracia 120, 7th Floor, 28003 Madrid, or to the email address [dataprotection@minor-hotels.com](mailto:dataprotection@minor-hotels.com) indicating in the reference “Data Protection” and attaching a copy of your identity document:

- Withdraw the consent granted for the processing and disclosure of your personal data, without affecting the lawfulness of the processing carried out prior to withdrawal.
- Obtain information on whether or not your personal data is being processed.
- Access your personal data.
- Rectify inaccurate or incomplete data.
- Request the erasure of your data when, among other reasons, the data are no longer necessary for the purposes for which they were collected.
- Restrict the processing of your data when any of the conditions set out in data protection regulations apply.
- Object, in certain circumstances and for reasons relating to your particular situation, to the processing of your data.
- Request the portability of your data.
- Lodge a complaint with the Spanish Data Protection Agency at **Calle de Jorge Juan, 6, 28001 Madrid**, if you believe that the Controller has infringed the rights granted to you under data protection regulations.
